1. A CLEAN, CLEAR COPY OF OWN CHOICE SELECTIONS FOR ADJUDITORS MUST BE SUBMITTED AS FOLLOWS.

Please submit a copy of own choice literary, Speech & Drama or Music selections including lyrics for mod/pop vocal sect, to reach the Eisteddfod Office no later than the above closing dates.

(If you wish to receive notification of receipt for all own choice submissions, please enclose a stamped self-addressed envelope or deliver to the eisteddfod office, in person, when officials are present.)

2. DOCUMENTS MUST BE ATTACHED TO THE **FRONT** EACH SUBMISSION AS FOLLOWS FOR ALL SUBMISSIONS

.....Title page - for identification for the adjudicator

.....Receipt – to be returned to the competitor if stamped self-addressed envelope is supplied or work presented in person.
See above note.

3. DOCUMENTS TO BE ATTACHED TO THE **BACK** OF EACH OWN CHOICE SUBMISSION

FOR INSTRUMENTAL, PIANO AND VOCAL SECTIONS

.....Copyright declarations to be attached to the back – **APRA form 2 & if necessary form 5**

FOR LITERARY AND OTHER OWN COMPOSITION SECTIONS

.....Statutory declaration. Stating work is the unaided effort of the competitor.
